**CONDITIONS**

- 1. All entries close at 10 a.m., three (3) days before scheduled race. Entries for BOTH race cards will close Monday, Aug. 8, 2022.
- 2. Online entries at [www.ustrotting.com](http://www.ustrotting.com) are encouraged.
- 3. Telephone entries to Pam Kenney at 216-287-6339.
- 4. Limited number of stall available.
- 5. No Lasix Veterinarian on the grounds. Lasix is the trainer's responsibility.
- 6. Current negative Coggins test is required.
- 7. OSRC and USTA Rules to govern with exceptions. Rules of HTCS to govern Stake Races.
- 8. Overnight events must have a least five (5) starters.
- 9. Track scores five (5) wide. Races split on eight (8).
- 10. Entry fees:  
\$100 per horse for HTCS Stake Races  
\$30 per horse for overnight events.
- 11. Purse division: 50%-25%-12%-8%-5%. Four (4) starters: 55%-25%-12%-8%. Three (3) starters: 60%-28%-12%. Two (2) starters: 65%-35%. One (1) starter: 100% - must go the course.
- 12. EIN or SSN for owners are required before any purse money will be paid.
- 13. The Ashtabula County Agricultural Society is not responsible for accidents on or off the track.
- 14. The Ashtabula County Agricultural Society reserves the right to postpone, declare off, change the program, or refuse any entry.
- 15. All HTCS Members should belong to Ohio Harness Horsemen's Association.
- 16. Buckeye Consortium passes honored at the gate on racing days only.
- 17. On-Track Accident Insurance Policy in effect.
- 18. Trotting Track Record: Bee in Charge 2:01.0 (2020)
- 19. Pacing Track Record: Elite Machine 1:56.3 (2020)
